The following Zoning Text Amendment Ordinance was adopted at the Tallmadge Charter Township Board meeting on July 10, 2012.

ORDINANCE NO. 06-19-12-1

ZONING TEXT AMENDMENT ORDINANCE

AN ORDINANCE TO AMEND THE TALLMADGE CHARTER TOWNSHIP ZONING ORDINANCE BY REVISING SECTION 15.05(H) – WHEEL STOPS.

THE CHARTER TOWNSHIP OF TALLMADGE, COUNTY OF OTTAWA, AND STATE OF MICHIGAN ORDAINS:

Section 1. Parking Lot Layout and Construction, Wheel Stops. Section 15.05(h) of the Zoning Ordinance shall be amended to state in its entirety as follows.

- (h) **Wheel Stops.** Wheel stops, curbing or a sidewalk of at least six (6) inches in height shall be installed for all parking spaces which abut a building, interior pedestrian walkway or public pedestrian walkway to prevent any vehicle from projecting beyond the parking lot area.

Section 2. Effective Date. This amendment to the Tallmadge Charter Township Zoning Ordinance was approved and adopted by the Township Board of Tallmadge Charter Township, Ottawa County, Michigan on July 10, 2012, after a public hearing as required pursuant to Michigan Act 110 of 2006, as amended; after introduction and a first reading on June 9, 2012, and after posting and publication following such first reading as required by Michigan Act 359 of 1947, as amended. This Ordinance shall be effective on July 29, 2012, which date is the eighth day after publication of a Notice of Adoption and Posting of the Zoning Text Amendment Ordinance in the *Advance Newspaper* as required by Section 401 of Act 110, as amended. However, this effective date shall be extended as necessary to comply with the requirements of Section 402 of Act 110, as amended.
