ORDINANCE NO. 021213-1

**FLOODPLAIN MANAGEMENT AMENDMENT ORDINANCE**

An ordinance amendment to Ordinance No. 81280, as amended by Ordinance No. 812A83 and Ordinance No. 091311-1, to designate flood hazard areas under the provisions of the State Construction Code Act, Act No. 230 of the Public Acts of 1972, as amended.

THE CHARTER TOWNSHIP OF TALLMADGE ORDAINS:

**Section 1**     **Designation of Regulated Flood Prone Hazard Areas.** Section 3.2 of Ordinance No. 81280, as amended by Ordinance No. 812A83 and Ordinance No. 091311-1, is restated in its entirety as follows.

The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) Entitled "Ottawa County, Michigan (All Jurisdictions)" and dated May 16, 2013; and the Flood Insurance Rate Map (FIRM) panel numbers of 26139C, 0143E, 0144E, 0165E, 0258E, and 0266E dated December 16, 2011, and panel numbers 26139C, 0232F, 0234F, and 0255F, dated May 16, 2013, are adopted by reference for the purposes of administration of the Michigan Residential Code, and declared to be part of Section 1612.3 of the Michigan Building Code, and to provide the content of the "Flood Hazards" section of Table R301.2(1) of the Michigan Residential Code. The FIS and FIRM shall be kept on file at the Tallmadge Charter Township Hall at 0-1451 Leonard Avenue, N.W., Grand Rapids, Michigan.

**Section 2**     **Repeals.**

All ordinances inconsistent with the provisions of this ordinance are hereby repealed.

**Section 3**     **Effective Date.**

This Ordinance was approved and adopted by the Township Board on March 12, 2013, after introduction and a first reading on February 12, 2013, and publication after such first reading as required by Public Act 359 of 1947, as amended. This Ordinance shall be effective on April 22, 2013, which date is at least 30 days after publication of this Ordinance.
