ORDINANCE NO. 06-16-15-1

ZONING TEXT AMENDMENT ORDINANCE

AN ORDINANCE TO AMEND THE TALLMADGE CHARTER TOWNSHIP ZONING ORDINANCE BY RESTATING SECTION 20.03 CONCERNING PENALTIES FOR VIOLATION OF THE ZONING ORDINANCE.

THE CHARTERTOWNSHIP OF TALLMADGE, COUNTY OF OTTAWA, AND STATE OF MICHIGAN ORDAINS:

Section 1. <u>Penalties</u>. Section 20.03 of the Zoning Ordinance shall be restated in its entirety as follows.

SECTION 20.03. PENALTIES. Any building or structure which is erected, moved, placed, reconstructed, razed, extended, enlarged, altered, maintained, or used, or any use of a lot or land which is begun, maintained, or changed, in violation of any term or provision of this Ordinance is a nuisance per se. Any person who violates, disobeys, omits, neglects, refuses to comply with, or resists the enforcement or any term or provision of this Ordinance or any amendment to it shall be responsible for a municipal civil infraction. The sanctions for a violation of this Ordinance shall be a civil fine of not less than two hundred fifty dollars (\$250.00), plus costs and other sanctions. Increased civil fines may be imposed for repeated violations of this Ordinance by a person. A "repeat violation" of this Ordinance is a second or subsequent violation of this Ordinance committed by a person within six (6) months of a prior violation of this Ordinance, and for which the person admits responsibility or is determined to be responsible. The sanction for a violation of this Ordinance which is a first repeat violation shall be a civil fine of not less than five hundred dollars (\$500.00), plus costs and other sanctions. The sanction for a violation of this Ordinance which is a second or subsequent repeat violation shall be a civil fine of not less than one thousand dollars (\$1,000.00), plus costs and other sanctions. A person who violates a term or provision of this Ordinance shall also be responsible to reimburse the Township for its legal fees incurred in the enforcement of this Ordinance.

Section 2. Effective Date. This amendment to the Tallmadge Charter Township Zoning Ordinance was approved and adopted by the Township Board of Tallmadge Charter Township, Ottawa County, Michigan on June 16, 2015, after a public hearing as required pursuant to Michigan Act 110 of 2006, as amended; after introduction and a first reading on May 12, 2015, and after posting and publication following such first reading as required by Michigan Act 359 of 1947, as amended. This Ordinance shall be effective on July 6, 2015, which date is the eighth day after publication of a Notice of Adoption and Posting of the Zoning Text Amendment Ordinance in the

Ottawa Advance as required by Section 401 of Act 110, as amended. However, this effective date shall be extended as necessary to comply with the requirements of Section 402 of Act 110, as amended.
